## **Introduction**

Maulana Azad Education Foundation (MAEF) was established to promote education amongst the educationally backward minorities in particular and other weaker sections in general.

Maulana Azad Education Foundation (MAEF) intends to establish a National Institute and a Hunar Hub at Village Khohra Peepli, Tehsil Kishangarh Bas, District Alwar, Rajasthan to impart conventional courses as well as skill based training , to provide education and research in multidisciplinary/ interdisciplinary areas of academic field.

**Area of Land: 61574.47 Sqm = 15.21 acres**

## **Scope of Work**

- Preparation of the Drawings with detailed/structural designs and specifications of the Boundary Wall including leveling of plot.
- Approval of the designs by Consultant from IIT.
- Approval of Plan by Town Planner, State Government Agencies.
- Proposed stone masonry wall of 18 inch width (thickness) and height of the wall to be assessed as 8 feet.
- A proposed gate with width of 20 feet and an additional entry gate for individuals.
- Approval to drawings for construction related activities shall be obtained from the local Authorities.
- Quality assurance and control to ensure conformance to drawings and specifications as per CPWD manual.
- Establish EHS plan (Environment, Health and Safety)
- Organize Progress review meetings on fortnight basis with MAEF
- A mandatory site visit will be organized by MAEF on 7<sup>th</sup> September 2020 to the interested Agency. The request should be made in advance.

## Eligibility Criteria

<b>Financial Stability</b>	<ul style="list-style-type: none"><li>• The average minimum turnover during the last three (3) financial years should be Rs. 5,00,00,000 (Rupees Five Crore Only)</li><li>• Annual Turnover Certificate by C.A. shall be submitted along with bid.</li></ul>
<b>Experience</b>	<ul style="list-style-type: none"><li>• Three similar completed works, each cost not less than the amount equal to 33% of estimated cost.</li><li>• Two similar completed works, each cost not less than the amount equal to 50% of estimated cost.</li><li>• One similar completed work costing not less than the amount equal to 100% of estimated cost</li><li>• The relevant documentary proof in the form of work orders and/or satisfactory performance certificates to be enclosed with the technical bid documents.</li></ul>
<b>Infrastructure/Legal</b>	<ul style="list-style-type: none"><li>• The Applicant should be a single entity and no consortium is allowed.</li><li>• The Applicant should be a Government of India Enterprise/Central or State Government Undertaking</li><li>• The Applicant should not be black listed by any Govt. Companies/Govt. organization/Govt. Agencies etc. in India or abroad.</li></ul>

Applicants will be required to provide additional information at the request of MAEF (if any) for (detailed) Proposal (RFP) stage, applications without required information or enclosures are liable to be rejected.
