

## AGREEMENT BOND

KNOW ALL MEN BY THESE PRESENTS THAT \_\_\_\_\_ a

in-after referred to as the Sanction Order) which forms integral part of these presents and a copy whereof

the Obliger the both hereby admit & acknowledge on the condition of the Obliger executing a bond in the  
terms and manner contained herein after which the Obliger has agreed to do so.

Now the condition of the above written obligation is such that if the Obliger duly fulfill and  
comply with all the conditions mentioned in the Sanction Order when the above written bond or  
obligation shall be avoid and of no effect but otherwise it shall remain in full force, effect & virtue.

- a) The decision of the Governing Body of the Foundation, concerned with the matter on the  
question whether there has been breach or violation on the part of the Obliger of any of the  
terms & conditions mentioned in the Sanction Order shall be final & binding on the Obliger
- b) The Obliger shall in the event of a breach or violation of any of the terms & conditions  
mentioned in the Sanction Order refund to the Foundation on demand & without  
demur the entire amount of \_\_\_\_\_ (Rupees \_\_\_\_\_ only) or such  
*(Grant sanctioned as mentioned in the Sanction Order)*  
part thereof Foundation may in its discretion mention in the notice of demand along  
with interest thereon at the rate of 18% (eighteen percent) per annum from the date of  
receipt of said amount by the Obliger up to the date of refund thereon to the Foundation.  
However, in default the amount would be recovered as arrears of land revenue.
