Advertisement for Empanelment of Agencies for providing Outsourced Manpower in MAEF

- 1. Maulana Azad Education Foundation (MAEF) is implementing various schemes like Seekho Aur Kamao, Scholarship, Grant-In-Aid etc. to promote education amongst educationally backward sections of the society. MAEF is fully funded by Ministry of Minority Affairs (MOMA), Govt. of India. MAEF invites applications from eligible agencies for empanelling them for providing Outsourced Manpower. The services of manpower would be utilized to undertake various activities in various divisions in MAEF office.
- 2. The eligibility criteria shall be as follows:-
 - (a) The agency must have Three years experience for providing similar type of services to any Central / State Govt Organisation / PSU / Public Listed Company. Copies of revenant contracts / orders must be attached in support of provided services during last Three years financial years.
 - (b) The agency should have minimum average annual financial turnover of ₹ 25 Lakhs(s) per year during the last three years, ending 31st Mar of the previous financial year. Documentary evidence of certified Balance Sheet by CA, along with last three years turnover as per certified Accounts / Balance sheet for the relevant period.
 - (c) The registered office of the agency should be located in Delhi or Delhi NCR.
 - (d) An undertaking should be given by the agency that agency is not blacklisted by any Government/PSU.
 - (e) The agency should provide the details of PF No., ESI Registration No. and MSME Status.
- 3. Terms of Empanelment shall be valid for FY 2022-23, which is extendable for another year as per requirement and MAEF. MAEF may, at any time, terminate

the empanelment by giving written notice to the empanelled agency without any compensation or liability, reason(s) if the empanelled agency commits any breach of contract, has misrepresented or becomes bankrupt or otherwise insolent, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to MAEF.

- 4. MAEF reserves the right to vary or cancel the process or any part thereof at its absolute discretion at any point of time.
- 5. Applications are invited in sealed envelope superscripted **as "Application for empanelment of Agencies for providing Outsourced Manpower in MAEF"**. Sealed envelope containing complete set of hard copy of application, empanelment fee, along with enclosures, should be submitted by post or to be delivered in person at MAEF office on or before 29 Apr 22.
 - (i) Application should be typed and submitted on A4 size paper, spirally and securely bound and all pages are therein serial numbered and in serial order.
 - (ii) All pages of the application should be duly signed. Any interlineations, erases or overwriting shall be valid only if the person(s) signs and authenticates them.
- 6. The last date for submission of Application with empanelment fee of ₹ 1000.00 is 29 Apr 22 up to 5:00 P.M. In case the designated day is declared a holiday, the next working day will be deemed as the last date for submission of Application.
- 7. On scrutiny, any application not found in desired format / illegible / incomplete / not containing clear information, or failing to fulfil the relevant requirement, will be rejected for further evaluation process at the sole discretion of MAEF.
- 8. MAEF reserves the right to accept or reject any or all applications received without assigning any reason whatsoever and the MAEF decision in this regard will be final. No contractual obligation whatsoever shall arise from the application process.
- 9. MAEF will not be responsible for non-receipt of applications within the specified date and time due to any reason including postal delays or holidays in between.
- 10. MAEF reserves the right to verify the validity of information provided in the application and reject any application where the information provided appear to be incorrect, in accurate or inappropriate at any time during the process of application / empanelment.
